When the Bollinger Bands are trending upwards, prices are typically between the middle and upper bands, with the middle and lower bands providing strong support. Conversely, when the Bollinger Bands are trending downwards, prices are usually between the middle and lower bands, with the middle and upper bands exerting significant resistance.

Using the daily chart of \$CLSK as an example, we can observe the typical characteristics of Bollinger Bands. Many may wonder why

we didn't sell when the price touched the upper band on the daily chart. The reasoning is based on two key points:

The first point is derived from the analysis of the weekly chart.

The weekly chart may indicate an imminent price breakout. By comparing the technical patterns at points B and A on the weekly chart, we can observe the following signs:

- 1. The price breaks above the middle band, indicating a strengthening price trend.
- 2. Volume increases significantly, showing a sharp rise in buying activity.
- 3. The MACD Histogram shortens below the zero axis, and the MACD Line and Signal Line at A2 form a bullish crossover. At B2, the MACD Line's downward angle is flattening.

Why do I say this? To be a good bottom fishing strategy, it must maximize rebound gains while controlling pre-rebound risks, and Leap Call does precisely that.



First, Leap Call has the rare quality of increasing gains as the price rises and decreasing losses as the price falls. When the stock price rises, Leap Call automatically increases its position, maximizing gains as the rebound occurs.

Conversely, if the price continues to drop before the rebound,
Leap Call reduces the position, minimizing losses as the price falls.
This effectively manages the risk before the rebound. Additionally, the holding cost of Leap Call is very low, giving us the confidence to wait for and position ourselves for the rebound. Let's look at an example:

Example: Consider the actual effect of bottom fishing with Leap Call. Suppose we use the Leap Call strategy on \$NVDA, currently priced at \$120, with a Leap Call strategy costing \$2500. In the ideal scenario where \$NVDA rebounds by 30% within a month, rising from \$120 to \$160, how much would this Leap Call earn? Keeping the market environment constant, this Leap Call could rise from \$2500 to \$5000, yielding a total profit of \$2500, or 100%. This is in the ideal case of a price rebound.



But what if the price doesn't rebound and instead drops? This scenario is where we must control the bottom-fishing risk. Suppose the worst case scenario occurs, and the price drops 30% within a month, from \$120 to \$80. For \$NVDA's stock, this is a significant drop. However, Leap Call provides a buffer, likely dropping from \$2500 to \$1300, a loss of about \$1200, or roughly 48%. So, with the same 30% movement, an increase could yield 100%, while a decrease only results in a 50% loss. In monetary terms, the gain from a rise is double the loss from a drop. If the price continues to rise or fall, this gap widens. This demonstrates Leap Call's significant advantage in bottom fishing.

However, it is essential to note that LEAP call is a leveraged operation. Despite buffered declines, it still fluctuates more than holding the equivalent amount of stock. Therefore, your risk control ability must keep pace. The scenario described assumes immediate price movement, but what if the price remains stagnant and only rebounds after a long period? This can be understood through the holding cost. The holding cost for LEAP



call is about \$5 per day, akin to an interest payment for potential rebound profits. This daily cost is manageable, whereas a one month option costs about \$20 per day. Note that as the option approaches expiration, time decay increases, raising holding costs. Thus, LEAP calls should not be held until expiration but closed around three months prior. If no rebound occurs by then, it's best to exit gracefully. However, if a rebound happens within nine months, substantial profits are assured.

Summary: Leap Call is a simple, risk controlled, and sufficiently profitable bottom fishing strategy. It serves as an entry level options strategy for bottom fishing. However, it also has drawbacks, such as high costs and limited explosive potential.
