## 2. Selection of Testing Assets

not need to repay the lost portion—only the remaining funds. If there are profits, you simply return the principal, and the profit portion can be withdrawn to your cryptocurrency wallet or bank account at any time.

It is emphasized that this test is crucial for us, and everyone must strictly adhere to the regulations to ensure the authenticity and validity of the test data. Your diligence and focus are the foundation of our success.

### Can You Use Your Own Funds for Trading?
