


Morning Review

In such a market environment, we need to be more cautious in formulating and executing our investment strategies to ensure we find the best balance between high risk and high returns.

This market atmosphere is also the core reason why our heavily held cryptocurrency beneficiary stocks have not experienced significant gains. The C2C trading is considered highly secure for several key reasons worth understanding and trusting.



Firstly, quality merchants participating in such transactions are required to deposit a significant security bond with the trading center. This measure ensures their strict regulation and provides a high degree of security and reliability for transactions. This not only demonstrates their legal and ethical commitment but also ensures they provide quality service to customers.

Secondly, C2C trading platforms are subject to strict regulation, such as oversight by the U.S. Financial Crimes Enforcement

Last week's stock market decline can partly be attributed to Google and Tesla's earnings reports falling short of expectations, which sparked investor concerns and led to consecutive plunges. This week is set to be exciting, with star stocks taking the stage. Tech giants with a combined market value of over \$10 trillion will release their earnings reports collectively. This could potentially deliver a "heavy blow" to the market because no one knows if these tech giants' earnings will meet market expectations. Consequently, the funds remaining in the stock market are like the Sword of Damocles hanging over investors' heads—a sharp sword suspended by a thin strand of hair, always threatening to fall. Smart money will not choose to trade at this time; they are all waiting for certain opportunities.

Therefore, I fully agree with the professor's view—retain quality

stocks and sell off those that are not worth holding. You can use these assets to participate in my 20 consecutive wins! All you need to do is vote for me and prepare your trading accounts!

So, after selling off our trash stocks, how should we seize the 20 consecutive wins? What constitutes certain opportunities?







In our last session, we discussed the L-pattern, which is a strong buy signal whenever it appears. As shown in the example, after the L-pattern appeared, the market maintained an upward trend, allowing us to easily achieve high profits using contracts.

Today, I will explain the V-shaped reversal pattern, another classic bullish pattern that is even more suitable for cryptocurrency contract trading. A V-shaped reversal typically indicates a possible market shift from a downtrend to an uptrend. Once a V-shaped pattern is established, it is highly likely to buy at the lowest point



of an upcoming bullish trend.

Characteristics of the V-Pattern (Refer to the Example Below):


V-Shape Bottom: The price forms a V-shaped bottom, characterized by a rapid decline to a low point, creating a clear bottom, followed by a swift reversal and an upward move.

V-Pattern Trait: The V-bottom is usually accompanied by an increase in trading volume, indicating strong interest from market participants in the price reversal. As more participants join, it often triggers a new upward trend.

V-Pattern Cycle: The V-shaped reversal pattern forms within a short period, reflecting the market's quick response and shift, emphasizing changes in market sentiment and liquidity.

V-Pattern Breakout: When the price breaks through the upward trendline from the V-bottom, it signifies a full reversal of the trend. The V-bottom marks the lowest point in this cycle.







Practical Analysis: A V-shaped reversal pattern is a buy signal because it indicates the start of a trend reversal from bearish to bullish. Once the selling pressure is exhausted, the buying force

begins to take over. The V-shaped reversal pattern is particularly suitable for short term intraday trading. By leveraging this pattern, you can capture the perfect main upward trend of a bull market.

As shown in the chart, the price experiences a sustained drop, reaching a low point and forming a bottom signal. Subsequently, the bears and bulls switch roles, the price begins to reverse and rise, and eventually breaks through the resistance zone. Let's see what interesting phenomena occur in the subsequent movements.

Afterward, the price soared, ushering in a perfect bottom reversal trend, buying at the lowest point of a new market cycle. It's worth noting that the V-shaped reversal pattern can be observed not only in candlestick charts but also in time share charts. Chart 2 shows a stock we traded before. Can you recall which option code this was? At that time, we successfully leveraged the V-shaped pattern to earn substantial profits, buying at the lowest point!
