PPI and CPI: Core inflation indicators that directly influence the Federal Reserve's interest rate decisions.

Initial Jobless Claims: Reflects the health of the labor market and affects economic growth expectations and stock market movements.

University of Michigan Consumer Sentiment Index: Measures consumer confidence in the economy, which has a massive impact on the stock market.

The release of these data will cause significant market fluctuations. If the data is consistent, we may see a strong trending market; if the data is mixed, expect volatile swings. This

Looking at the 4-hour chart, the current price is approaching a resistance zone, and the decreasing volume during the upward movement indicates that buying pressure is weakening. This suggests that the market has not yet shown any technical signs of a price reversal.

From this, we can draw two wise conclusions:

- Gradually selling during price rebounds is the best strategy to maintain profits.
- Acting now and selling ahead of the curve will allow you to seize the market advantage.
