most effective strategy is to sell high and buy low: sell near the upper band and buy near the lower band.

Take SPX as an example. Since October 2022, although it has seen a long term upward trend, whenever the middle Bollinger Band runs horizontally, prices tend to fluctuate rather than rise continuously. Currently, a rate cut in September seems almost certain, but we face challenges from the Sam Rule, the Mrs. Watanabe case, Buffett's selling logic, and the potential risks of a "sucker rally."

In light of these challenges, the wisest approach remains selling when stock prices rise. The recent rebound in indices has exceeded expectations, and while the market has been kind to us, we must not become complacent. Does everyone understand and agree with this perspective? Let us continue to stay vigilant, grasp the true movements of the market, and ensure we achieve the best returns amid volatility!



Dear Friends,
