

The M-top is characterized by a double-peak structure, suggesting that the bullish momentum is weakening while bearish forces are gaining strength. Once this pattern is confirmed, it often leads to a significant price correction or decline.

The KDJ indicator in the sub-chart has also formed a "death cross"! The last time we saw such a strong bearish signal, the index dropped by about 12%. During that decline, the entire stock market turned into a sea of red, with many popular stocks plummeting. What's even more critical is that the most important earnings report of the year is imminent—\$NVDA is set to release its Q2 FY2025 earnings after the close this Wednesday. This report is expected to stir up massive waves in the U.S. stock market!
