



## Morning Review

Historical evidence suggests that in such scenarios, the stock market often crashes. The resurgence of inflation and the weakening labor market make the prospect of a "soft landing" even more uncertain, and rate cuts may not be able to boost the stock market.

Statistics show that after six of Powell's speeches at the Jackson Hole Symposium, the S&P 500 Index experienced declines over the following three months in five instances, with an average drop of 7.5%.

-- In May, the BLS accidentally released the Consumer Price Index (CPI) data 30 minutes early.
