


Morning Review



Good morning, dear students and partners, I'm James Wilson.
Yesterday, NVIDIA's post market earnings report caused
significant turmoil, with the stock plummeting by as much as 8%.
This outcome was entirely in line with my predictions. On Tuesday and Wednesday of this week, I presented the following view:

NVIDIA's earnings report was bound to be impressive, and the guidance for the next quarter should also be strong. However, given the extremely high market expectations, any slight

disappointment would trigger an urgent risk-off strategy by investors. The focus wasn't on the earnings themselves but on whether the Blackwell chip would face further delays.

As it turned out, NVIDIA's second-quarter gross margin was negatively impacted by the low production of Blackwell material inventory, and the revenue forecast fell short of the market's most optimistic expectations. This has fueled concerns that NVIDIA's explosive growth might be slowing down. Additionally, the much-anticipated next-generation Blackwell chip production has indeed encountered obstacles, leading to a sharp drop in the company's stock price during after-hours trading.

NVIDIA's Blackwell design issues have been confirmed, with the company's CFO admitting yesterday that there are indeed production problems.

So, how should we assess the current market situation?

First, we must understand that the market is driven by short-term

expectations. Therefore, once the panic subsides, the market is likely to return to rationality. Next, we should shift our focus to the market's future concern—the U.S. economic situation.

The data shows:

The U.S. Q2 real GDP annualized quarter-over-quarter growth was revised up to 3%, from an initial estimate of 2.8%. Initial jobless claims for the week ending August 24th decreased by 2,000, seasonally adjusted to 231,000.

The U.S. economy, particularly consumer spending, is showing a certain level of resilience. Combined with last week's unexpectedly sharp decline in initial jobless claims, this further solidifies the expectation that the Fed will only slightly reduce interest rates in September. This is bearish for stock indices but bullish for the dollar. A 25-basis-point rate cut in September is far below market expectations, as the current rebound was fueled by the anticipation of a more significant rate cut.

As a result, this will likely lead to an unwinding of the funds that

drove the recent rally, and the stock market will face substantial selling pressure.

It's clear that the current U.S. stock market isn't offering opportunities to make substantial profits. And the purpose of investing is to make money. So today, I want to focus on a crucial point: How can you invest in a way that leads to life changing wealth?






