Good morning, dear students and partners. I am James Wilson.

Today marks the final trading day of the week and the "Decisive Day" for Phase Two—a critical moment that will determine victory or defeat. On the data front: The U.S. core PCE price index for July rose 2.6% year over year and 0.2% month over month, both holding steady from previous values. This is the Fed's "favorite" inflation measure. The fact that the core PCE price index did not continue to expand suggests that inflation is moving toward the Fed's target, further boosting expectations of a slight rate cut in September.

Earlier, we discussed the reasoning behind NVIDIA's stock price decline. Despite an impressive earnings report, the stock still triggered significant selling by investors. The reason lies in "high expectations." For investors who held high hopes, NVIDIA's Q3 revenue outlook, which was only \$2 billion above the market average, simply wasn't enough. The same logic applies to interest rate cuts: the market isn't just looking for a 25 basis point reduction; it's hoping for a substantial cut to release more liquidity. This is why the outlook for the stock market remains



bearish in the short term, even though it may be positive in the long run.

But time is money, and who has the luxury to wait for long term benefits? The longer the time frame, the greater the risk. Over such an extended period, who knows what might happen? War? Natural disasters? Human made catastrophes? We can't predict the future. The only certainty in life is its uncertainty. That's why I always urge everyone to seize the present. If you live each day to the fullest, you're already in control of your future.

I'm fully aware that the ultimate goal of investing is to make money. Theoretically, the more you earn, the better, but in reality, the investment cycle is equally crucial. Given the choice between a 5000% return over ten years and a 500% return in six months, I would choose the latter without hesitation. Why? Because the future is inherently uncertain.

Looking at NVIDIA's earnings report, the numbers aren't bad—\$30 billion in revenue, a 122% year over year increase, and FB Finance Institute - 15th Session



a net profit growth of 168% to \$16.6 billion, all in line with market expectations. But the surprise factor is gone. This trillion dollar giant, once the symbol of a meteoric rise, is now showing signs of slowing down. As the leader in the AI industry, NVIDIA's performance is often seen as a barometer for the entire AI sector, and even the global market. If demand for their AI chips remains strong, the AI-driven "wealth creation frenzy" could continue. However, as the cards have now been laid on the table, NVIDIA's board approved an additional \$50 billion stock buyback to soothe shareholders' concerns.

But this doesn't truly reassure investors, because during the "earnings call", Jensen Huang couldn't address the market's most pressing questions.

What are the market's biggest concerns?

First, whether NVIDIA can maintain its strong technological edge.

Before the earnings call, industry insiders already knew that

Jensen Huang's highly anticipated Blackwell chip was facing

production "delays." Huang had confidently stated during the Q1 earnings call that Blackwell would significantly contribute to the company's revenue this year. However, on the day of the Q2 earnings report, CFO Colette Kress acknowledged production issues with Blackwell, indicating that the company is working on design improvements to boost output, with shipments now postponed to the fourth fiscal quarter. This has raised significant concerns about NVIDIA's future growth.

Second, whether big tech companies can truly profit from AI to sustain this ongoing boom. This is crucial because the level of investment from major tech firms in AI is enormous. While it hasn't reached the extremes of the 2000 dot-com bubble, it still poses a considerable risk. The market was looking to NVIDIA's earnings report to see if their customers are actually making tangible profits from their AI investments.

Jensen Huang didn't directly address either of these concerns.

Instead, to calm shareholders, he approved an additional \$50

billion stock buyback. What does this indicate? It suggests that a

crisis is already looming.




