How Deep Will the Index Fall?

Let's take \$IXIC as an example. Currently, the S2 point is lower than the S1 point, which is a key phenomenon in trend trading, indicating that the market trend has already taken shape. Today, we'll explore the trend from a new perspective:



- Uptrend: When the periodic lows continue to rise—for example, low point B6 is higher than B5, and B5 is higher than B4—this defines the uptrend in the T2 range.
- Downtrend: When the periodic highs continue to fall—for example, high point S4 is lower than S3—this defines the downtrend in the T1 range.

If we compare the T1 range with the T3 range, the prices in T3 will likely fall below the B1 position. Therefore, the index still has a considerable decline ahead.

Currently, the MACD Line and Signal Line have already formed a bearish crossover, signaling that the downward trend is just beginning. Following this, the Bollinger Band midline will likely turn downward, which will further accelerate the decline in the stock index.
