

Last Friday, I introduced the idea that the stock index is likely to break below the early August lows, which sparked lively



discussion. To better understand this, we can visualize the process using simple wave theory:

Wave 1: Bull market initiation.

Wave 2: Profit-taking, slight pullback.

Wave 3: Main upward phase of the bull market.

Wave 4: Mid-term investors exit early.

Wave 5: Market sentiment reaches a peak, accelerating the rise.

Wave A: Downward movement begins, with volume divergence.

Wave B: Volume fails to increase significantly, signaling the best exit opportunity.

Wave C: Main downward phase, with strong declines, large drop, extended duration, and broad market sell-off.



Dear friends,

It's foreseeable that September will be a challenging month for the big tech companies.

During the Jackson Hole symposium, the Federal Reserve sent an important signal—interest rate policy is gradually stepping away from the center stage, and the future of the U.S. stock market will be more reliant on economic fundamentals. However, the U.S. economy has already entered a recessionary cycle, and whether it can achieve a "soft landing" remains uncertain. Coupled with the uncertainty surrounding the U.S. presidential election, the market



is facing increased pressure. Therefore, regardless of how the market fluctuates in the short term, this year's bull market can essentially be declared over.

It's important to note that the driving force behind U.S. stock market rallies has never been retail investors, but rather Wall Street's institutional players. Last week, a Goldman Sachs report made it clear that regardless of whether the market rebounds or adjusts in the short term, major institutional investors have already begun gradually selling off stocks. This suggests that the "September curse" could very well trigger a wave of concentrated sell-offs.


Given my previous points, is the future direction now clear to everyone?
